

Lakeview

Ninety Four Feet (NFF), ABN 15 547 845 925, is the developer for the Lakeview project, and subject to the Privacy Act 1988 and the Privacy Amendment (Enhancing Privacy Protection) Act 2012.

This Privacy Policy has been provided to demonstrate the commitment that NFF has to ensuring the protection of privacy for our prospective purchasers and future residents (Customers).

Any data that NFF collects during your use of lakeview.nz (Website) will only be used in accordance with current Australian data protection legislation, as well as our privacy policy.

How we collect your data

This Website uses cookies on certain pages. These cookies are stored on your hard drive, not on our Website. Most cookies are “session cookies” which means that they are automatically deleted at the end of each session. A cookie itself does not have the ability to automatically collect personal information about you. A cookie can however store certain information that identifies your computer to us, so that you don’t have to re-enter information as frequently when you use our site. We may also collect your IP address to help diagnose problems with our server or to gather broad demographic information.

Registration form

Our Website’s optional “Registration Form” (Form) asks users to give us contact information including your name, email address and phone number. Submission of the Form requires users to check a tick box to indicate that they have read and agree to the Website Terms and Conditions (Terms). Per these Terms, the details provided by the Form are automatically added to the NFF customer database (Database). The Database is used by NFF and their associated partners to contact you by phone, mail or email. See “Database Use” section below. Such email messages will provide you with an unsubscribe option, which you can use to request not to receive further emails.

Database use

We use the Database collected from the Website Form to send emails regarding sales launches, news, updates, changes in our services, and other information that we believe will be of interest to our Customers. Customers may choose to opt-out of receiving future communications – see the “Unsubscribe” section further below for more details. Demographic and profile data that is collected by our Website may be shared with advertisers and our partners only on an aggregate basis, meaning that your personally identifying information is not shared.

If you send us personal correspondence, such as emails or letters, or if other users or third parties send us correspondence about your activities or postings on our Website, we may collect such information into a file specific to you. We use information in the file that we maintain for you, and other information that we obtain from your use of the services, to resolve disputes, troubleshoot problems and enforce our Terms of Use agreement.

We cannot ensure that all of your private communications and other personally identifiable information will never be disclosed in ways not otherwise described in this Privacy Policy. For example, we may be forced to disclose information to the government or third parties under certain circumstances, or third parties may unlawfully intercept or access transmissions or private communications. We can (and you authorize us to) disclose

any information about you to law enforcement or other government officials as we, in our sole discretion, believe necessary or appropriate in connection with an investigation of fraud, intellectual property infringements, or other activity that is illegal or may expose us to legal liability.

Sales agents

NFF partners with sales agents (Agents) who are contracted on behalf of NFF to perform marketing and sales tasks in relation to Customers. Agents are required to adhere to the NFF Privacy Policy and may additionally have their own Privacy Policy as well.
